Elder Law

Attorney Gwendolyn K. Christeson concentrates her practice in Probate and Trust law.

A Conservatorship of the Person is a protective court proceeding to appoint a conservator for a person who cannot properly provide for his or her personal needs for physical health, medical care, food, clothing, or shelter.

A Conservatorship of the Estate is a protective court proceeding to appoint a conservator for a person who is substantially unable to manage his or her own financial resources or to resist undue influence.
